Separate sealed bids for construction of the Commonwealth Crossing Business Centre 1 Million Gallon Elevated Water Tank Project will be received by the Henry County Public Service Authority at Room 210, Purchasing Department of the Henry County Administration Building in Martinsville until 3:00 p.m. local time on October 26, 2017 and then publicly opened and read in the 1st Floor Summerlin Board Room.

The project consists of the construction of a 1 million gallon elevated composite water storage tank, 12 ft wide access road, yard piping, and related appurtenances and improvements at the Commonwealth Crossing Business Centre. The project will also include an altitude valve at the Chestnut Knob ground storage tank, and a flow control valve located along Soapstone Road.

Bidders must certify that they do not or will not maintain or provide for their employees any facilities that are segregated on the basis of race, color, creed, or national origin.

The procedure for withdrawal of bids shall be according to provision "(ii)" contained in Title 2.2- 4330, Code of Virginia (1950) as amended.

The bidder shall place on the outside of the envelope containing the bid and shall place in the bid over his signature the following notation:

An optional Pre-Bid Conference will be held at 10:00 a.m. on October 11, 2017 at the 1st Floor Summerlin Board Room of the Henry County Administration Building located at 3300 Kings Mountain Road, Martinsville, Virginia.
